## LOCATION

The site is located to the south west of the city centre in the Gorgie district of Edinburgh on the A71/Gorgie Road, which is one of the main arterial routes into and out of the city of Edinburgh.

The property benefits from a prominent frontage onto Gorgie Road and the surrounding area is of a mixed residential and commercial nature. Tynecastle Football Stadium is located nearby and Haymarket Railway Station is within a 15 minute walk of the subjects which also benefit from being located on a major bus route.





## DESCRIPTION

The site is cleared and level with access taken directly off the A71/Gorgie Road, extending to approximately 0.0304 HA (0.075 Acres).

The subjects formerly comprised retail premises which have been demolished and is being sold subject to and with the benefit of vacant possession.

#### PLANNING

Previously consent was granted for a mixed commercial and residential development.

Architects plans are available outlining a proposal for a development providing 34 student residential units. There is potential for 18 residential flats on site, subject to planning consent being granted.
