Fort William is the largest town in the Highlands with estimated catchment of 25,000 persons. However as a centre for hillwalking and climbing, its proximity to Ben Nevis, amongst other mountains, and as the start/end of the West Highland Way, it attracts approximately 500,000 tourists annually.

Furthermore, this area boasts the Nevis Range Ski Resort and is a major centre of world mountain biking in addition to a variety of outdoor pursuits.


